**TERMS and CONDITIONS - from September 2018**

**TAKE NOTICE (1):** Notice is hereby given that I charge for the time I must spend dealing with you and / or with your solicitors or any other legal representative/s for the matters pertinent to your defamatory website <http://www.tariqsiddiqi.co.uk/> or for any content published anywhere of similar nature and purpose.

Here I included my full terms and conditions with the relevant fees:

From now on, if during the course of our relations, I am put to any inconvenience (as deemed an 'inconvenience' by me) or forced to respond to any harassing, defamatory or vexatious form of litigation that the fee schedule contained herein shall apply. An example of inconvenience is where I am required and or asked to investigate, research and or undertake any work (administrative communicative and or otherwise) in order to assist you in performing your obligations and or correcting your error and mistakes then following charges will become payable within twenty-one (21) days of demand;

- (1) For reading your letters/emails with any distressing and or untrue statements and or threatening and or defamatory and or any unnecessary vexatious content or statement: up to **£150.00** per letter depending upon content and length of the letter which may require legal research or consultation with legal counsel.
- (2) For constructing letters/emails in response to you or to any legal representative acting on your behalf and causing me unnecessary distress and or inconvenience as described above: up to **£80.00** x hour per depending upon length of the letter/correspondence.
- (3) For receiving inbound telephone calls: from a minimum **£80.00 x hour**
- (4) For making and or initiating telephone calls: from a minimum **£80.00 x hour**
- (5) For any other task involving the use of my time in dealing with you or with any legal representative acting on your behalf; also for each correspondence initiated by you or by the court further to your request causing me unnecessary distress and or inconvenience: **£150.00 per hour\*** - \* whereas this charge is in response to your ongoing conduct damaging my reputation and financial state of affairs by ethical violations, illegal abuses, and fraud which I am facing since you published defamatory and harassing content online from 2012 and as a deterrent measure to prevent further stressful experiences to my detriment and to that of my family members.

I will notify you with the total costs and losses I incurred with regard to the above matters pertinent to your defamatory website <http://www.tariqsiddiqi.co.uk/> or for any content published anywhere of similar nature and purpose.


In the event you refuse to pay I will notify the full amount/s and add my accrued fees and charges (with added interest calculated at 8% annually) to the list of damages and costs I have already incurred because of your actions.
